### **CDC UPDATES COVID-19 GUIDANCE FOR SCHOOLS**

On Thursday, August 11, the Centers for Disease Control and Prevention (CDC) **loosened** its guidance for preventing the spread of coronavirus, shifting the responsibility away from schools, businesses, and institutions and onto individuals. Schools will no longer need to screen seemingly healthy students and employees, and the CDC is putting less emphasis on social distancing, dropping the “six foot” standard. The CDC has also removed the quarantine rule for unvaccinated individuals, with the Agency focusing now more on vulnerable populations and how to protect them. The CDC guidance does not change regarding the wearing of masks indoors in “high-risk level” communities, but few school systems have a mask mandate still in place. The guidance does say that schools “should consider flexible, non-punitive policies and practices to support individuals who choose to wear masks regardless of the COVID-19 Community Level.” Secretary of Education Miguel Cardona **said** “this latest guidance from the CDC should give our students, parents, and educators the confidence they need to head back to school this year with a sense of joy and optimism. While COVID continues to evolve, so has our understanding of the science and what it takes to return to school safely.” He continued, “Thanks

to vaccines, boosters, new treatments, and commonsense safety precautions – as well as funding from the American Rescue Plan – our schools have more resources than ever before to provide the healthy learning environments our students need to grow and thrive academically, socially, and emotionally.” Additional news reports from the [Washington Post](#) and [Chalkbeat](#) have helpful background information.
