## 1. COSSBA Policy Priorities

### TEACHER-PRINCIPAL TRAINING AND RECRUITMENT

#### EDUCATORS RELEASE JOINT STATEMENT ON TEACHER SHORTAGE SOLUTION

On Wednesday, September 21, a number of professional organizations for teachers **released** a joint statement on sustainable systems for quality teaching. The signatories include the: American Council on the Teaching of Foreign Languages (ACTFL); American Association of Physics Teachers; Association for Career and Technical Education; Association for Multicultural Science Education; International Technology and Engineering Educators Association (ITEEA); National Association of Biology Teachers (NABT); National Council for the Social Studies; National Council of Teachers of English; National Council of Teachers of Mathematics; National Middle Level Science Teachers Association; National Science Teaching Association; and the Society for College Science Teaching. The statement details solutions for the national teacher shortage crisis and argues that short-term solutions will not correct the systemic issues that existed prior to the pandemic; that “filling classrooms with under qualified individuals” is not the answer. “Instead, we must create a sustainable system that prepares, retains, and supports teachers through accessible, high-quality teacher preparation, competitive compensation, ample resources, and ongoing professional learning and mentoring opportunities,” the statement explains. It continues, “These commitments demonstrate that educators are professionals and are critical to our social infrastructure and progress as a nation. Their positive impact on their students helps to ensure that we have a vibrant society and skilled workforce in the future.”

## 2. Budget and Appropriations Wrap-Up

The end of Fiscal Year (FY) 2022 is less than a week away, and Congress has not yet approved a continuing resolution (CR) to keep the federal government operating in FY 2023. Democrats and

Republicans continue to negotiate the terms of a CR, likely to extend government funding for at least two months.

Senate Democratic leaders hope to vote on a bill this week that would support federal operations through December 16<sup>th</sup>, with a House vote to follow. Outstanding issues include emergency funding for COVID, Ukraine and natural disasters; whether to include policy proposals, such as Senator Joe Manchin's (D-WV) permitting proposals and renewal of free school lunch waivers; and, how long the temporary funding bill will last. To the duration of the CR, Democrats, want a bill that funds the government through December 16<sup>th</sup> to give Congress time to finalize an omnibus spending package before the end of the calendar year. Republicans would prefer a bill that goes into 2023, so that if either chamber ends up with a Republican majority after the elections, they will have more influence on the final spending package. Of course, the education advocacy community continues to press for increased funding levels as outlined in the House's FY 2023 Labor, Health and Human Services, and Education spending bill, versus the smaller increases proposed by Senate appropriators.

Republicans are optimistic about their chances for taking control of the House in the next Congress, and last week Minority Leader Kevin McCarthy (R-CA) and his colleagues unveiled their "Commitment to America" outlining priorities for a Republican-led House. The proposal includes a pledge to "Make sure every student can succeed and give parents a choice." The pledge's tenets include advancing the "Parents' Bill of Rights," recovering "lost learning" from school closures, expanding parental choice options, and ensuring "only women can compete in women's sports." The details on these tenets are scant, but Republican candidates are being encouraged to use them and the larger plan on the campaign trail.

While there doesn't seem to be any appetite for high-drama around the end of the fiscal year and passing a spending bill to prevent a federal government shutdown, an election year means that high-drama can appear without much notice. Advocates will be watching lawmakers closely next week.

### **How does this impact State School Board Associations?**

The 2023 appropriations process, including the eventual CR, will ultimately determine how much money is allocated for the Department of Education and the programs that provide critical support at the district and school level. If a CR is passed through mid-December, the Department of Education will be funded at 2022 levels until 2023 spending bills are passed. Additionally, there are discussions that a renewal of free school lunch waivers might be included in the CR, as mentioned above. If there were a short term shut down of only a few days, because money for education is mostly forward funding, there would likely be little to impact on public schools.

### **3. In Brief – Last Week in Washington**

#### **ASPEN INSTITUTE EXAMINES EDUCATION FRAMEWORK FOR THE FUTURE**

On Monday, September 19th, the Aspen Institute Education and Society Program held an event titled, "Opportunity to Learn, Responsibility to Lead: A Bipartisan Public Education Framework for the Future." The event featured Linda Darling-Hammond, president of the California State Board of Education; Angélica Infante-Green, Commissioner of Education for Rhode Island; and

Iowa State Senator Amy Sinclair (R-14), majority whip and Senate Education Committee Chair. The panel came together to discuss new bipartisan “Opportunity to Learn” (OTL) Principles for state leadership in education, which were developed by a group of state policymakers and education officials based on their visions, values, and the examination of research evidence on opportunities for students in public schools. The Principles cover essential elements of the student experience, the learning conditions schools are responsible for, and the unique role of state leadership. Darling-Hammond opened the event by introducing the OTL Principles and gave commentary on how the California State Board of Education is implementing them. Darling-Hammond spoke on the importance of a holistic approach to childhood education and stressed the significance of networking public schools with private educational providers to ensure that students have every tool to succeed available to them. Infante-Green gave insight to Rhode Island’s metrics and how the state has used the OTL principles to conduct annual surveys concerning the climate of schools across the state. Infante-Green explained that they use this data to provide aid to districts for infrastructure, while also prioritizing students' needs. Sinclair expressed that “students have the right, the constitutional right, to become civically engaged and prepared students,” and the means to achieve this in a healthy and safe environment. Sinclair highlighted that Iowa state government is responsible for setting up a framework of success for students so that they are supplied with the same opportunities wherever they receive their education. The panel also explored inquiries regarding ways in which school personnel can adopt OTL principles; how states will be held accountable; and what the policy implications are at the federal level. #### **ED AND LABOR COMMITTEE EXAMINES SOCIAL AND EMOTIONAL LEARNING**

On Tuesday, September 20, the House Education and Labor Subcommittee on Early Childhood, Elementary, and Secondary Education held a hearing on “Meeting Students’ Academic, Social, and Emotional Needs.” Witnesses included Phyllis Jordan, associate director of FutureEd; Dr. Aaliyah Samuel, President and CEO of the Collaborative for Academic, Social, and Emotional Learning (CASEL); Dr. Penny Schwinn, Commissioner of Education for the Tennessee Department of Education; and Dr. Matthew Blomstedt, Commissioner of Education for the Nebraska Department of Education. The panel shared state and district specific data on how their communities and schools are addressing student learning loss as a result of the pandemic, and several provided substantive details on how their states and districts are using Elementary and Secondary Emergency Relief (ESSER) and American Rescue Plan (ARP) funds. Committee members on both sides of the aisle underscored the pandemic’s impact on children, families, and communities and agreed that while the initial shift to online learning saved lives, not being in the classroom hindered students’ social and emotional development and disrupted their academic experience. Despite this bipartisan sentiment, Republican members iterated their concern that states and school districts are not spending their federal dollars responsibly and expressed an apprehension that Social Emotional Learning programs are overshadowing more traditional academic subjects like math and reading.
