What is NCSBT?

- The North Carolina School Boards Trust (NCSBT) was formed in 1982 by the North Carolina School Boards Association to provide NC boards of education with an alternative to commercial insurance
- NCSBT is the only member-funded, member-managed risk management program in the state designed specifically for NC boards of education
- NCSBT is currently celebrating 40 years of continuing to provide necessary risk management protection and service to its members.






What is NCSBT?

- ► For more than 40 years, NCSBT has continued to provide several coverages to its members through its three funds:
 - ► Workers Compensation Fund provides members with statutory workers' compensation coverage for their locally and federally funded workers' compensation exposures
 - ▶ Errors & Omissions/General Liability Fund provides coverage to member boards for various general and school board legal liability exposures while allowing them to preserve their immunity from state tort and negligence claims. This program also provides an excess no-fault medical expense reimbursement coverage ("medical expense") for eligible accidental injury claims of school guests and students
 - ➤ Automobile Inland Marine Fund provides automobile liability coverage for non-yellow school bus and physical damage exposures, as well as for authorized yellow school bus uses that are not subject to the North Carolina State Tort Claims Act. This Fund also provides members with inland marine coverage for their miscellaneous scheduled equipment


