1. COSSBA Policy Priorities

INDIVIDUALS WITH DISABILIITES EDUCATION ACT (IDEA) \$224M AVAILABLE TO IMPROVE SERVICES FOR STUDENTS WITH DISABILITIES

The Department of Education's Rehabilitation Services Administration (RSA) is <u>inviting</u> <u>applications</u> for its <u>Disability Innovation Fund -- Pathways to Partnerships Innovative</u> <u>Model Demonstration Project</u>, the largest discretionary grant administered by RSA, with approximately \$224 million available to fund multiple innovative projects managed through partnerships among state vocational rehabilitation agencies (SVRAs), state and local education agencies (SEAs and LEAs), and centers for independent living (CILs). "Funded projects will focus on the creation of systemic approaches to improve access to pre-employment transition services. The goal is to pave a clear and robust path to independent living and competitive, integrated employment as individuals with disabilities move from high school to postsecondary

endeavors," the RSA press release says. The deadline for applications from eligible SVRAs and SEAs is June 5.

CHILD NUTRITION

USDA EXTENDS COMMENT PERIOD for SCHOOL NUTRITION STANDARDS PROPOSAL

The USDA Food and Nutrition Service is <u>extending</u> the public comment period on the proposed rule, "Child Nutrition Programs: Revisions to Meal Patterns Consistent With the 2020 Dietary Guidelines for Americans," which published in the Federal Register on February 7, 2023. This action extends the public comment period from April 10, 2023, to May 10, 2023, to give the public additional time to review the proposed rule. As of Friday, USDA received 74,133 comments on its proposal to make gradual yet significant changes to school nutrition requirements on whole grains, sugar and sodium. The USDA's proposal would require schools to offer mostly whole grain products beginning in fall 2024, with gradual sugar and sodium content reductions occurring through 2029.

2. Budget and Appropriations Wrap-Up

Congress was in recess the previous two weeks, but is back in session this week and busy. The House Labor, Health and Human Services and Education Appropriations Subcommittee will **host Secretary of Education Miguel Cardona** on Tuesday to discuss the fiscal year 2024 Department of Education budget. Leaders from other agencies will be keeping members of the Committee occupied all week at other hearings on those agencies' budget. The House Education and the Workforce Subcommittee on Early Childhood, Elementary and Secondary Education will hold **a hearing on school choice** on Tuesday as well. On the other side of the Capitol, the Senate Health, Education, Labor and Pensions Committee will hold **a hearing** on the nomination of Julie Su to serve as the Secretary of Labor.

As Congress returns, there will undoubtedly be more conversations by House Republicans on how to address the country's debt limit and cut spending. It has been reported that the proposal being developed by the GOP would lift the debt limit until May 2024, cap non-defense discretionary funding for FY 2024 at FY 2022 levels, allowing for 1% growth thereafter, and install work requirements on Medicaid and other government programs. The debate of what and how to cut is ongoing, but <u>a list</u> of proposals being considered was published by Politico. House Appropriations Committee Ranking Member Rosa DeLauro (D-CT) has mounted efforts to oppose cutting spending to FY 2022 levels, and the White House released <u>state fact sheets</u> detailing the effects such cuts would have.

Passing a budget that provides a topline spending number allows the Appropriations Committee to begin its work. In the absence of a budget, Leadership will determine that topline number, which Committee leaders will divide across the twelve spending bills and allow staff to start writing bills. The Senate will follow after the House, and advocates will approach each Chamber in support of funding priorities.

How does this impact State School Board Associations?

We have previously reported on the proposed Republican FY24 budget cuts and how they could impact public education. In addition, Education Secretary Miguel Cardona wrote a <u>letter</u> describing the effects of such cuts to education funding.

3. In Brief – Last Week in Washington

ED ISSUES PROPOSED RULE CHANGE TO TITLE IX STUDENT ATHLETICS ELIGIBILITY

On April 6, the Department of Education (ED) released a notice of proposed rulemaking (NPRM) on athletic eligibility under Title IX. ED says the rule change will "advance Title IX's longstanding goal of ensuring equal opportunity in athletics." Based on two years of stakeholder outreach to develop the proposed rule, ED says they found that many schools, students, parents, and coaches were uncertain about when and how transgender students can participate in school sports, due in part to the increasing number of states that have adopted new laws and policies on transgender student athletics participation. "The NPRM, if adopted as a final rule, would provide much needed clarity for students, parents, and coaches," ED says. According to ED's press release, the NPRM would: 1) Establish that policies violate Title IX when they ban transgender students from participating on sports teams consistent with their gender identity, 2) recognize that in certain competitive athletic environments, such as college sports, some schools may adopt policies that limit transgender students' participation, and 3) provide schools with a framework for developing eligibility criteria that protects students from being denied equal athletic opportunity, while giving schools the flexibility to develop their own participation policies. "Every student should be able to have the full experience of attending school in America, including participating in athletics, free from discrimination," said Secretary of Education Miguel Cardona. Today's proposed rule is designed to support Title IX's protection for equal athletics opportunity. We welcome and encourage public comment on the proposed regulation and will continue working to ensure Title IX's effective protection for all students," he continued. The ED's NPRM will be open for public comment for 30 days from the date of publication in the Federal Register. A full summary of the NPRM is here.

ED PUBLISHES STUDENT HEALTH RECORD GUIDANCE FOR SCHOOL OFFICIALS

On Wednesday, April 12, the Biden Administration announced <u>new actions to safeguard</u> <u>patient privacy</u>, including protecting students' health information with <u>guidance for school</u> <u>officials</u> and a <u>know your rights resource</u>. This guidance document for school officials provides officials with general information about the Family Educational Rights and Privacy Act (FERPA), with a particular focus on student health records maintained by educational agencies and institutions and by third parties acting on their behalf.
